THE PROGRAM TRAINS PARENTS IN THE USE OF EFFECTIVE STRATEGIES FOR PROMOTING SECURE AND HEALTHY RELATIONSHIPS BETWEEN CAREGIVERS AND YOUNG CHILDREN. THE CURRICULUM-BASED SERVICE OFFERS SPECIFIC GUIDELINES FOR STRENGTHENING CHILD/CAREGIVER RELATIONSHIPS IN WAYS THAT MEET CHILDREN'S NEEDS, FOSTER DEVELOPMENT AND ENHANCE FEELINGS OF SELF WORTH.
